1. EMERGENCY CARE CLINICAL PRACTICE GUIDELINES

Earlier this year, upon the request of our members, the Society lodged an enquiry with the HPCSA seeking clarity on the status of emergency care protocol updates.

The HPCSA has subsequently issued a public notice advising the profession that we can expect rigorous changes to emergency care protocols as we know them and that certain outputs in this regard can be expected by mid-June 2016.
